That the undersigned, as President and Secretary of SILVER CREEK OF CLAY COUNTY HOMEOWNERS ASSOCIATION, INC. (hereinafter "Association"), pursuant to the Florida Statutes and the ARTICLES OF INCORPORATION OF SILVER CREEK OF CLAY COUNTY HOMEOWNERS ASSOCIATION, INC., recorded in Official Records Book 2332, Page 0274, of the Public Records of Clay County, Florida, as amended and supplemented (hereinafter "Articles"), hereby certify that the ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SILVER CREEK OF CLAY COUNTY HOMEOWNERS ASSOCIATION, INC., which amendment is attached hereto and by reference made a part hereof (hereinafter "Amendment"), was duly adopted at a meeting of the members on the 30 day of September, 20 15 (hereinafter the "Meeting").

Said Amendment was approved at the Meeting in accordance with the requirements of Article XI of the Articles by the affirmative vote of at least a majority of the Members. Proper notice was given for the Meeting pursuant to the Articles and Bylaws of the Association and the Florida Statutes. The Notice of the Meeting stated the purpose, time, date and location of the Meeting.

The Association is a homeowners association created pursuant to the laws of the State of Florida. With the exception of the attached Amendment, all other terms and conditions of the Articles shall remain in full force and effect.

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SILVER CREEK OF CLAY COUNTY HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of §617.1006, Fla. Stat., SILVER CREEK OF CLAY COUNTY HOMEOWNERS ASSOCIATION, INC. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment adopted:

Article VIII, Section A, and Article XI, Section A of the Articles of Incorporation of Silver Creek of Clay County Homeowners Association, Inc. ("Articles of Incorporation") are hereby amended as follows (additions are indicated by underlining; deletions are indicated by ~~strike-out~~, omitted and unaltered provisions are indicated by ellipses):

ARTICLE VIII. BOARD OF DIRECTORS

A. The business affairs of this Association shall be managed by the Board of Directors. The number of members of the Board of Directors shall be three including the President of the Association as provided in the Bylaws of Silver Creek of Clay County Homeowners Association, Inc., as recorded in Official Records Book 2332, Page 0280, et. seq., of the Public Records of Clay County, Florida, as may be amended or supplemented from time to time.

ARTICLE XI. AMENDMENT OF ARTICLES

- A. These Articles of Incorporation may be amended as follows:
 - 1. Amendments shall be proposed by a majority of the Board of Directors.
 - 2. The President, or acting Chief Executive Officer of the Association in the absence of the President, shall thereupon call a special meeting of the Members of the Association for a date not sooner than twenty (20) days nor later than sixty (60) days from the date on which the Board of Directors approve the amendment proposal. Each Member shall be given written notice of such meeting stating the time and place of the meeting and reciting the proposed amendment or amendments in reasonably detailed form, which notice shall be mailed or presented personally to each Member not less than ~~ten (10)~~ fourteen (14) ~~nor more than thirty (30)~~ days before the date set for such meeting. Such notice shall be deemed properly given when deposited in the United States mail, addressed to the Member at his post office address as it appears on the records of the Association. ~~At such meeting, the amendment or amendments proposed must be approved by an~~

~~affirmative vote of at least a majority of the members.~~ These Articles of Incorporation may be amended by the affirmative vote of a majority of the Owners who are voting in person or by proxy at a meeting of the Members at which a quorum has been attained (e.g., once a quorum of those Owners attending in person or by proxy has been obtained at a regular/annual or special meeting of the Members of the Association, a majority of those Owners attending the meeting in person or by proxy may amend these Articles of Incorporation). If so approved, a certified copy of the said amendment or amendments shall be filed in the Office of the Secretary of State of the State of Florida and recorded in the public records of Clay County, Florida.

SECOND: The date of adoption of the Amendment was the 30th day of September, 2015.

THIRD: Adoption of Amendment:

Article XI, Section A(2) of the Articles of Incorporation, in effect prior to the adoption of the instant Amendment, provides that amendments to the Articles of Incorporation may be approved by the affirmative vote of at least a majority of the members.

The members of the corporation were entitled to vote on the Amendment. The members of the Association duly adopted this Amendment in accordance with the above-stated provision. **The number of votes cast for the Amendment was sufficient for approval.**

THE ASSOCIATION has caused these presents to be executed in its name, this 2nd day of October, 2015.
