AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SILVER CREEK

The following amendment is made to Article VII, entitled "General Provisions," of the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SILVER CREEK, recorded in Official Records Book 2332, Page 0250, et. seq., of the Public Records of Clay County, Florida (additions are indicated by <u>underlining</u>, deletions are indicated by <u>strikethrough</u>, and omitted but unaltered provisions are indicated by ellipses):

ARTICLE VII XII – GENERAL PROVISIONS

. . .

Section 3. Amendment. The covenants and restrictions of this Declaration shall run with and bind the land, for a term of twenty (20) years from the date this Declaration is recorded, after which time they shall be automatically extended for successive periods of ten (10) years.

This Declaration may be amended during the first twenty (20) year period by an instrument signed by not less than ninety percent (90%) of the votes of each class, and thereafter by an instrument signed by not less than seventy five percent (75%) of the Owners. Any amendment must be recorded in the public records of Clay County, Florida. This Declaration may be amended by the affirmative vote of a majority of the Owners who are voting in person or by proxy at a meeting of the Members at which a quorum has been attained (e.g., once a quorum of those Owners attending in person or by proxy has been obtained at a regular/annual or special meeting of the Members of the Association, a majority of those Owners attending the meeting in person or by proxy may amend this Declaration).

Any amendment to the Covenants and Restrictions which alter the surface water or stormwater management system, beyond maintenance in its original condition, including water management portions of the common areas, must have the prior approval of the St. Johns River Water Management District.
